During the committee meeting, Executive Officer Nick Dolata informed the committee that there had been requests for more frequent meetings. As the result, the committee agreed to hold Non-Student Citation Committee Meetings at the end of the summer, spring, and fall semesters. Eric Harris suggested scheduling the summer semester meeting after August 1st.

Additionally, Nick briefed the committee on the results of the Transportation, Parking, and Infrastructure (TPI) Fee Student Survey, which was distributed in February. The survey sought students' opinions on installing a parking garage and implementing a flat, all-encompassing TPI fee set at \$125 per semester. The majority of students voted against these proposed changes.

Finally, the chair asked if there were any additional matters to address, but none were brought forward. A motion to adjourn the meeting was made, and the meeting ended at 3:31 p.m.
