Proceedings:

A motion to approve the agenda of February 22, 2017, as distributed, was made by Mr. Wilson. Dr. Rand seconded. Motion APPROVED.

Mr. Wilson moved approval of the minutes from January 25, 2017. Motion seconded by Dr. Rand. Motion APPROVED.

Mr. Wilson moved approval of revised Electronic Nicotine Delivery Systems (Electronic Cigarettes) Policy No. 171 (pending the establishment of the new board of governance). Seconded by Dr. Rand. The updated policy prohibits the use of electronic nicotine delivery systems, including electronic cigarettes, on Tennessee Tech property. Motion APPROVED.

A motion was made by Mr. Wilson to approve the revised Counseling Center Policy No. 350 (pending the establishment of the new board of governance). The motion was seconded by Dr. Rand. The revised policies represents the current clinical services at the Counseling Center. Motion APPROVED (with friendly amendments).

Mr. Wilson made a motion to approve the new Personal Conveyance Vehicles Policy. 191 (pending the establishment of the new board of governance). Dr. Rand seconded. The policy prohibits the possession, use, and storage of Personal Conveyance Vehicles on Tennessee Tech property or during any Tennessee Tech sponsored activity. Following discussion, a verbal vote was taken with three votes of nay. Motion PASSED.

A motion for blanket approval of revised Business and Fiscal Affairs policies was made by Mr. Wilson. Dr. Rand seconded. Policies 570 and 571 are effective upon approval; all other revised polices are pending the establishment of the new board of governance. Motion APPROVED (with friendly amendments).

"Illicit Discharge Detection Policy No. 402" is established to improve quality of surface water and ground water by decreasing contaminated stormwater runoff from Tennessee Tech properties.

"Budget Control Policy No. 501" details clear and specific responsibility for proper budget management and control at Tennessee Tech.

"Budget Principles Policy No. 501.1" is intended to respond to the expectations of various stakeholders relating to the generation and expenditure of funds.

"Collection of Accounts Receivable Policy No. 504" provides the criteria and process for collection of all accounts receivable at Tennessee Tech.

"Revenue Collection, Receipting and Reconciliation Policy No. 504.1" establishes standards for proper collection, receipting, and reconciliation of all funds.

"General and Group Travel Policy No. 506" sets forth appropriate reimbursement rates and guidelines for all expenses incurred on official business travel for Tennessee Tech.

- "Payment of Student Fees and Enrollment Policy No. 511" provides guidance regarding student accounts including charges, payments, and enrollment.
- "Fees, Charges, Refunds, and Adjustments Policy No. 511.1" is intended to outline significant provisions for consistent administration of fees, charges, and refunds at Tennessee Tech.
- "Student Fee Adjustments, Refunds, and Appeals Policy No. 511.2" describes the procedures for making fee adjustments and refunds.
- "Deferred Payment Plan Policy No. 511.3" sets forth standards for implementing and communicating about deferred fee payments.
- "Delegation of Signature Authority Policy No. 512" establishes the process for delegation of signature authority for Tennessee Tech employees.
- "Uniform Disposition of Unclaimed Property Policy No. 513" sets forth appropriate procedures for complying with Tennessee's Uniform Disposition of Property Act.
- "Cash and Gift Card Payments to Research Participants Policy No. 515" establishes a process for low dollar payments to research participants through the use of cash or gift cards.
- "Financial Performance Review Policy No. 520" details appropriate policies and procedures for performing a financial performance review.
- "Key Control Policy No. 561" establishes procedures and regulations to protect Tennessee Tech's property and ensure that keys are issued and retrieved with proper controls.
- "Contracts and Agreements Policy No. 570" details the rules pertaining to acquisition of goods and/or services through contracts and agreements.
- "Purchasing Policy No. 571" establishes the methods of procurement used by Tennessee Tech and provides an explanation of various steps and actions within the procurement processes.
- "Unpaid Leave of Absence Policy No. 619" sets forth the criteria and process for unpaid leave of absence.
- "Employment of Minors Policy No. 640" establishes the restrictions and conditions for employment of minors.
- "Compensation policy No. 644" details the criteria and processes for employee compensation at Tennessee Tech.

A motion for blanket approval of revised Athletics policies (pending the establishment of new board of governance) was made by Dr. Smith. The motion was seconded by Dr. Mills. Motion APPROVED.

"Organization and Responsibilities of the Department of Athletics Policy No. 902" delineates the organization and responsibilities of Department of Athletics staff members.

"Compliance Policy No. 903" details regulations for compliance to NCAA and Ohio Valley Conference Legislation as well as Tennessee Tech.

"Athletics Financial Aid Policy No. 907" defines financial aid sources and award guidelines for Intercollegiate Athletics.

"Student-Athlete Appeals Related to Financial Aid or Permission to Contact Another Institution Policy No. 909" provides for a student athlete appeals process in the event of nonrenewal or reduction of aid or denial of permission to contact for transfer.

"Athletics Finances and Budget Controls Policy No. 910" provides clear and specific responsibility for proper budget management and control of Tennessee Tech Athletics.

"Tennessee Tech Approved Athletic Recognitions Policy No. 911" delineates the policies and procedures for retirement of athletic jerseys and other recognitions that are presented in the name of Tennessee Tech or purchased by Tennessee Tech.

"Recruiting Policy No. 913" details the policies and procedures for recruitment of prospective student-athletes within NCAA, OVC, and institutional guidelines.

"Scheduling and Contracts Policy No. 917" describes the policies and procedures for scheduling practices and competitions for Intercollegiate Athletics.

"Athletics Tickets Policy No. 920" delineates the policies and procedures for ticketing admission and security associated with competitions for the intercollegiate athletics programs at Tennessee Tech.

"Facilities and Equipment Policy No. 925" defines the athletic facilities and the policies and procedures associated with practice and competition for intercollegiate athletics. This also includes the Department of Athletics policy regarding equipment.

"Athletics Travel Policy No. 930" addresses practical considerations for travel related specifically to the performance of intercollegiate athletic recruiting and athletic team travel.

"Concussions Policy No. 952" provides Tennessee Tech University sports medicine staff and coaching staff with standard procedures for immediate medical care of athletes with potential head injuries.

"Sports Camps and Clinics Policy No. 960" defines the policies and procedures associated with athletics camps and clinics at Tennessee Tech University.

"Sports and Athlete Agents Policy No. 965" provides information to student athletes and their families regarding agents, as well as State of Tennessee agent laws and NCAA legislation regarding agents.

"Amorous Relationships (Athletics) Policy No. 970" provides a safe and healthy environment for student-athletes so that they may reach their full potential as students and as athletes, and to ensure that coaches and other staff members adhere to ethical practices and do not develop inappropriate relationships with student-athletes, regardless of age or consent.

A motion was made by Mr. Wilson for approval of New Academic Units Policy No. 227 (pending the establishment of the board of governance). Dr. Rand seconded the motion. This policy establishes an approval process for new academic units at Tennessee Tech, consistent with the corresponding policy (A1.3) of the Tennessee Higher Education Commission. Motion APPROVED.
