Approved annual reports of committees reporting to the Administrative Council for 2022-2023.

Elected Vice-Chair for Administrative Council 2023-24.

Proceedings:

Chair Sandi Smith-Andrews called the Administrative Council meeting to order at 3:35 p.m. Holly Mills motioned to approve the agenda for April 5, 2023. Mary Lou Fornehed seconded. Motion APPROVED.

Fornehed motioned to approve the March 1, 2023 minutes. Mills seconded. Motion APPROVED. One Abstained.

Smith-Andrews noted the revised Faculty Promotion Policy No. 206 was submitted as a second reading and, therefore, the policy will be available for an actionable vote. Fornehed motioned to approve the policy, Mills seconded. Mark Stephens presented and stated that changes were made according to the suggestions given at the first reading. Stephens noted that it was presented at the Academic Council for a first reading and the Academic Council was fine with the suggested changes. No further discussion. Motion APPROVED. Stephens offered his appreciation and stated the policy would be presented the following week at Academic Council for the second reading.

Fornehed motioned to approve the Athletics Annual Report for 2022-23: 1) Diversity Issues and, 2) Gender Equity. Kristine Craven seconded. Mark Wilson presented and stated both reports were approved by the Athletics Committee. Richard Rand congratulated Wilson on the Girls Basketball Team for doing so well in the NCAA Tournament and asked if the win benefited Tennessee Tech financially? Wilson replied there was not a direct cash distribution to Tech but value of the exposure that Tennessee Tech received during the tournament in radio, press, television and social media was exceptional and at an amount that we could not afford to purchase so that was tremendous. Wilson stated that NCAA Women's Basketball Championships at the present time do not have a financial distribution that goes along with that success. Motion APPROVED.

Smith-Andrews stated that Administrative Council had received 19 reports and 47 pages from committees reporting to Administrative Council. Fornehed motioned to approve and accept the annual reports for 2022-2023. Mills seconded. Smith-Andrews asked for discussion and there was none. Smith-Andrews noted there were some typos and she would contact the committees directly since it was just editorial. Motion APPROVED.

Smith-Andrews opened the floor to nominations for vice-chair of the Administrative Council for the year 2023-24. Fornehed, chaired the nominating committee along with Mills and Andrea Kruszka. Fornehed stated there were no nominations received by the committee and asked the Administrative Council members for self-nominations or nominations by someone else. Craven
