Proceedings:

A motion to approve the agenda of August 24, 2016, as distributed, was made by Mr. Wilson and was seconded by Dr. Ballal. Motion APPROVED.

Mr. Wilson moved approval of the minutes from April 6, 2016. Dr. Ballal seconded. Motion APPROVED.

Mr. Wilson moved approval of the Constitution of the Women's Club Soccer of TTU. The motion was seconded by Mr. Martin. The purpose of the Women's Club Soccer of TTU is to promote a healthy lifestyle through competitive soccer. Women's Club Soccer aims to teach students concepts of soccer in hopes of winning as many games as possible. Motion APPROVED.

A motion to approve the Amended Constitution of the Student Environmental Action Coalition of TTU was made by Mr. Wilson. The motion was seconded by Dr. Ballal. The purpose of the organization is to act as agents of environmental education and change by addressing the environmental impact of our educational institution and our society. The purpose of the amendment is in regards to the dissolution of the organization, upon which all funds of the organization would be distributed to the Evergreen Society of Tennessee Tech University. Motion APPROVED.

Dr. Jeff Roberts provided a briefing regarding the FOCUS Act transition of policies. All policies are being reviewed as they become available by a five member team comprised of the current and past senate presidents.

Mr. Wilson made a motion to approve the rescinding of Allergy Injections Policy No. 363. Mr. Macke seconded. The policy related to the administering of allergy shots for eligible Tennessee Tech students and employees; however, as this is an internal matter, the policy is not required. Motion APPROVED.

Mr. Wilson moved approval to receive the Weapons on Tennessee Tech Property Policy No. 422. Dr. Ballal seconded. The policy became effective on July 1, 2016, as enacted by the President upon action of the Legislature. The policy describes the prohibition of the possession of weapons on Tennessee Tech Property (such as carrying weapons to university events) and describes the limited exceptions to the prohibition. This policy applies to TTU employees. Motion APPROVED.

A motion was made by Mr. Wilson to approve the Policy on Policies No. 101 (pending new governance board establishment). The motion was seconded by Dr. Ballal. The policy creates uniform procedures for the orderly development, amendment, revocation, review and approval of policies related to Tennessee Tech's university-wide procedures. Motion APPROVED.

Dr. Roberts made a motion to approve revisions to Scholarship Policy No. 254 (pending new governance board establishment). The motion was seconded by Dr. Ballal. The policy provides consistency and fairness with regard to the strategic use of scholarships awarded to students. Revisions have been made accordingly regarding the FOCUS Act and Tennessee Board of Regents policies. The revisions also provide that the deadline to apply for scholarships shall be extended. Motion APPROVED.

Mr. Burnett motioned to approve revisions to Eagle Card Policy No. 311 (pending new governance board establishment). The motion was seconded by Mr. Wilson. The policy provides students and employees with a Tennessee Tech identification card. Revisions were made to remove TBR policies from Policy No. 311. An employee section has also been added under the revisions. Motion APPROVED.

A motion was made by Mr. Burnett to approve revisions to Class Excuse Policy No. 362 (pending new governance board establishment). The motion was seconded by Mr. Wilson. The policy describes the practice related to issuing medical excuses for missed classes. Revisions were made to remove TBR policies from Policy No. 362. Motion APPROVED.

Chief Nelson made a motion to approve revisions to University Police Complaint Procedure Policy No. 411 (pending new governance board establishment). The motion was seconded by Mr. Wilson. The policy describes the process by which a complainant may file an official complaint against a Tennessee Tech University police officer. Revisions were made to remove TBR policies from Policy No. 411. The structure for filing a complaint has also changed under the revisions. Motion APPROVED.

Administrative Council Page 4, August 24, 2016

A motion for blanket approval of the following nine revised policies was made by Mr. Wilson and seconded by Dr. Ballal. All policies are pending the establishment of the new board of governance.

"Parental Leave Policy No. 612" establishes the conditions for parental leave.

"Bereavement Leave Policy No. 613" establishes the conditions for bereavement leave.

"Voting Leave Policy No. 614" establishes the conditions for voting leave.

"Jury Duty Policy No. 615" establishes the conditions for civil leave.

"Disaster Relief Service Leave Policy No. 621" establishes the restrictions and conditions for disaster relief service leave.

"Alternate Work Arrangements Policy No. 626" establishes and details Tennessee Tech's policy and procedures regarding alternate work arrangements for employees.

"Benefits in the Event of an Employee Death Policy No. 633" establishes the criteria and process for benefits in the event of an employee death.

"Retirement Policy No. 663" sets the standards for consistent process and treatment of employees regarding retirement.

"Consensual Relationships Policy No. 686" establishes and details Tennessee Tech's policy and procedures regarding consensual relationships.

The motion was APPROVED by unanimous vote.

Dr. Ballal moved to adjourn, and the motion was seconded by Mr. Martin. Meeting ADJOURNED at 3:58 p.m.
