6. Campus Safety Briefing - Tony Nelson

- a. Chief Tony Nelson informed the committee that reported crime on campus has been low. Only a few reports of minor crimes.
- b. Security Assessment with THEC was completed in November. Homeland Security couldn't make the meeting but the University got a lot of good feedback due to the work Facilities did with updating lighting and locking mechanisms across campus.
- c. Security Cameras have been added to Lab Science and Athletic Performance Center. It is University Police's goal to eventually have security cameras in all campus buildings.

7. Status of EHS Projects - Rob DeCheske

- a. Emergency Operation Plan was sent to departments for comments and has now been sent to the President's Office for signature.
- b. THEC reached out to the University about statewide drills. EHS has responded that the University would like to participate in an extreme weather drill. THEC will reach back out with a timeframe for that drill once response have been received from other Universities. Leadership has asked that a tornado drill be done and should take place within the next two to three weeks.
- c. The University received a notice from TOSHA on Friday (1/28/22) about a complaint. EHS responded on Tuesday (2/1/22) and within four hours of response a notice was received that the complaint had been closed.

8. Such Other Matters

- a. Rob DeCheske brought before the committee that he would like to start a Chemical and Lab Safety subcommittee. This item will be added to the agenda for the next committee meeting for a vote to be taken.
- b. Chuck Roberts brought before the committee that THEC has reached out to Jim Cobb about special dedicated safety and security funding. Funding is estimated to be \$1.2 million. The current plan is to use this funding for projects such as the traffic circle in front of Bell Hall.
