Students' use of resources or facilities typically available to students in their educational activities does not constitute significant use. College of Arts & Sciences, Department of Sociology & Political Science-New Academic Program Proposal, MSW

Dr. Steven Seiler stated addition of new Master of Social Work hybrid, 60 credit hour program with two tracks, Advanced Generalist Practice and Substance Abuse and Mental Health, and an accelerated option within each track. College of Arts & Sciences, Department of Biology-New Academic Program Proposal & Addition of Curriculum Courses – Ph. D in Integrative Biology

Dr. Bradley Cohen stated the proposed PhD program in Integrative Biology addresses a critical workforce need in Tennessee and beyond for doctoral-level scientists who can bridge traditional boundaries between subdisciplines of biology and broader disciplinary divides. According to the U.S. Bureau of Labor Statistics and THEC's 2024 Supply and Demand Report, employment for biological scientists is projected to grow by 7.2% in Tennessee through 2032, outpacing the overall state employment growth rate of 6.8%. After little discussion, Dr. Stacey Browning MOVED approval and Dr. Allen MacKenzie SECONDED. APPROVED unanimously.
