Committee Reports

Committee for MLK Week of Service

Charria Campbell reported that there were about a total of 20 student volunteers for the events. Two students accompanied Charria to the Dollar Tree to shop for food for the pantry in the Library. Ten students went to Walmart to shop for food items for the main food pantry. A team of students waited at the library to help with stocking the shelves. Another group was at the Tech village food pantry to assist with restocking shelves there.

Book Drive

Ten students volunteered to help with the book drive. Over 1000 books were distributed to four locations. Two distribution sites were Head Start programs. The other two locations were areas that provided books to all ages.

Students participating in the MLK week events were encouraged to share and post photos of their service in social media. An increase in student participants this year was noted. Simone McKelvey mentioned that it would be nice if CSB used some funds to benefit students. Launch Pad had contacted the Marketing Manager in the dining hall who printed off "Dining Dollar" vouchers that could be used in the awards drawings for student volunteer efforts. Symone shared the process of getting this approved. A memo requesting such action must be first sent to Dr. Stinson for her approval. Once approved, the request can be sent to the marketing manager of the Caf.

Black History Month Report

Arthur Banton congratulated Krystal Akehinmi and team members Troy Smith, and Edward Driggers in the operation of the Black History Month Quiz Bowl. It was reported that the first day of the Quiz Bowl there was one response. Second day there were 20 responses with 13 correct entries. The third day there were 21 responses with 11 correct entries. The fourth day there were 18 responses with 13 correct entries.
