IT Committee Mission or Purpose


Provides:

- 2) Communication for the strategic and tactical planning of information technology from a university perspective



ATAC Responsibilities

Discuss technology issues that affect faculty	Assess needs and develop proposals for technology initiatives that support GPC's goals and objectives
Alert IT Services to strategic support issues and emerging technology needs	Develop proposals for technology initiatives that provide TTU with a competitive advantage and will aid in attracting and retaining students, faculty, staff and external support
Advise IT Services regarding strategic support needs and any issues that, if unresolved, would jeopardize the successful completion of approved technology initiatives	Provide report to the CIO for inclusion in the strategic plan annually, by Nov I

ATAC Responsbilities (cont)

Provide representatives to the Student Technology Access Fee competitive proposal review committee	Appoint faculty member co-chair or designee to report to ITC in fall and spring semesters to demonstrate the committee has completed responsibilities listed in this charter
Serve as liaison between IT Services and faculty for the purposes of disseminating information related to technology	Aid in developing or reviewing an annual faculty use survey
Appoint faculty member co-chair or designee to serve on the Information Technology Council (ITC)	

Student Technology Advisory Committee (STAC) Mission

- Provides advice and guidance to the Chief Information Officer (CIO) and Information Technology Advisory Committee (ITAC) on issues related to student use of technology. The STAC is charged with:
 - Serving as 'the' voice for student technology needs for both operational purposes and strategic purposes, and
 - Collects and solicits ideas from the student body
