Mr. Brandon Walls provided Systems Support Update as follows:

- Multifactor Authentication Push Notification Number Matching
 - Microsoft enforcing mid-February
 - Phased rollout
- New Unstructured (File) Storage Solution
- Virtualization Storage Firmware Upgrade
 - o Tentatively Scheduled for December 22, 2022
- Upgrades to Server Virtualization and Virtual Desktop Infrastructure
 - Replacing aging hardware
 - o Increase capacity of both storage and compute
 - Increase capacity for Virtual Machines
 - o Increase support for Applications that require heavy graphics support
 - Hardware support for Windows 11 and beyond
