# Cl11 - Multidisciplinary Studies Curriculum, Generalist, B.S. / Catalog Changes - Effective F24

## Cl12 – Graduate Catalog Changes – Effective Fall 2024

Discussion: The department would like to update the transfer credit catalog wording for our Specialist in Education program under the General Degree Requirements for the Ed.S. degree. We are requesting it be identical to our master's degree program wording for transfer credits. Vote called: All in favor, motion passed.

#### C13 – Undergraduate Program of Study Removing READ 3314 – Effective Fall 2024

Discussion: Previous change requests were submitted to the 2/22/2024 UCC for this program. These are additional changes. As state and CAEP standards have changed, the State Board of Education updated and refined testing requirements for Middle School majors. With the removal of the TRE exam, faculty have re-evaluated coursework and built in advisor-guided electives to better meet students' needs for content specific coursework (such as history content courses, computer science education add-on courses, or ESL add-on courses). This change will enable middle school majors to add licensure specific coursework in areas of high demand. Vote called: All in favor, motion passed.

Within the choices, students can take three (3) CSED courses to earn their endorsement in Computer Science Education and Library Science. Both CSED and LSCI will continue to require passing the appropriate Praxis exams.

It was not being taught regularly because there was not sufficient time in the program of study for teacher licensure candidates and few others showed interest in becoming a certified instructor. With recent changes in requirements from the State level, the current program of study needs to be updated and this course will fit in nicely and benefit the teacher candidates as they go into the teaching profession.

The exercise science concentration will provide students with multiple opportunities to study in areas within exercise science that are most interesting to them while providing a rigorous and well-rounded education.

- ❖ State Literacy Standards Report & EPP Foundational Literacy Skills Review Plan
  - Pursuant to T.C.A. § 49-5-5607, the department is required to conduct an annual review of EPP implementation of foundational literacy skills standards to be included in EPP annual reports as well as published in the State Board of Education Educator Preparation Report Card. To meet this requirement, EPPs will submit evidence demonstrating instruction is aligned with all applicable foundational literacy standards.
  - > Timeline
    - February 23, 2024: The TN Department of Education released literacy review process requirements.
    - May 23, 2024: Education Preparation Providers (EPPs) submit literacy review requirements to the department.
    - July 22, 2024: The TN Department of Education will provide feedback to EPPs.
