WHAT ARE BENCHMARKS AND WHY ARE THEY IMPORTANT?

The Office of Teacher Education uses the term "benchmark" to describe the different levels of requirements that must be completed throughout all TTU licensure programs. The benchmark checklist can be used by students to stay on track with all levels of requirements and deadlines in order to obtain their teaching license.

There are three sets of benchmarks. One is for undergraduate students who are on the Residency path for all majors excluding Music. The second is for undergraduate students who are on the Residency path majoring in Music. The third is for post-baccalaureate (graduate) students who are on the Student Teaching path. Therefore, it is very important that you follow the correct set of benchmarks so you do not get behind in your program. Please contact your advisor if you are unsure of your specific program path.

Dispositions

The Office of Teacher Education has recently updated the "Disposition" processes for admission to the program and entrances into clinical experiences. The new disposition is a two-part process in which a candidate completes a self-assessment and the assessor (instructor, advisor, supervisor or mentor teacher) completes the corresponding disposition assessment. ETS Praxis Updates

1. As of August 31, 2020, TREE: 5203 is no longer accepted for licensure. If you *have already taken (and passed)* the TREE before *August 31, 2020*, **no action is needed**. If you are registering for a test date **after** the **Praxis: 5203 exam expiration of August 31, 2020**, you must register for Praxis 5205: Teaching Reading Elementary.

2. ETS has decided to eliminate testing windows for most Praxis exams, with the exception of exams with low volume. Test registration has opened with availability each month. The increased testing window may affect score reporting dates. Please refer to the <u>ETS site</u> for test dates and expected reporting dates.

3. If you feel you did not perform to your potential, you may retake a *Praxis* exam **once every 35 days, not including your initial test date**. This also applies for Proctor U at-home exams. For example, if you take a test on the first of the month, you cannot take it again until the 5th day of the following month, assuming 31 days in a month. **Note:** If you take a test that is comprised of subtests, such as Elementary Education: Multiple Subjects (5001), you cannot retake a subtest until after the 35-day period. This applies even if you canceled your scores on a test taken previously. <u>If you violate this restriction, the</u> <u>scores from your retest will be canceled by ETS and your test fees will not be refunded.</u>

4. ETS is still offering at-home exams. You may view more information regarding the at-home option <u>here</u>. **Note:** *Score reporting for at home testing may differ from in-person test center score reporting.*

5. As of August 31, 2020, Tennessee will no longer accept passing scores on the CORE Academic Skills for Educators for test codes: Reading (5712), Writing (5722), and Mathematics (5732). Candidates must submit passing scores for the new test codes: Reading (5713), Writing (5723), Mathematics (5733), and the combined test (5752) beginning September 1, 2020.

OTE Test Prep

OTE coordinates the Test Prep course available via iLearn. This course provides a variety of resources and study materials for those preparing to take the ACT, Praxis CORE, Praxis II, NES, GRE, and MAT tests.
