Below is a message from President Oldham regarding the Fall 2020 Schedule.

As we prepare campus for the return of students this fall, we are making key decisions to help students, parents and the campus community make plans.

We have made a decision about the start and length of fall semester. We began and ended the conversation by reflecting on what Tech students have said they needed to be the most successful.

After weighing several options and considering extensive input from representatives across campus, the decision has been made to keep the original semester schedule start date, take scheduled breaks and end with final exams taken in the classroom.

• Plans focused on everyone's health and safety take shape daily, and our campus will be ready with modifications and precautions necessary to welcome everyone back.

• The mental, physical and emotional toll of the changes during spring and summer semester leave us committed to making decisions that help students have the college experience they desire and expect.

• There is a strong desire by the campus community to have final exams in the classroom.

• With increased summer enrollment, many students and faculty have forgone typical schedules and breaks.

• Planning on a normal schedule gives the university flexibility if COVID-19 patterns change dramatically in our community.

If state and national COVID-19 protocols change during the semester, we stand ready to adjust as needed. We cannot predict the future, but we will always put students first.

IMPORTANT: Praxis Tip

When registering for a Praxis exam, your ETS account shows that entering your social security number is "optional". However, the Tennessee Department of Education will not enter your Praxis score(s) into the state licensure system if your social security number is not on the ETS/Praxis score report. This means, if you fail to enter your entire, correct social security number in your ETS account, you will have to contact ETS, have your social security number added, and pay an additional fee to have scores resent before the Department of Education will issue your teaching license. You can save yourself anxiety and money by entering your entire, correct social security number each time you register for a Praxis exam.

IMPORTANT: Prospective Teacher Candidates

The codes for Praxis CORE exams are changing to the following: CORE math (5733), CORE reading (5713), and CORE writing (5723). Passing scores will be accepted for both current and new exams through August 31, 2020: CORE math (5732 and 5733), CORE reading (5712 and 5713), and CORE writing (5722 and 5723). Passing scores for these exams <u>will not change</u>.
