#### Call to Order

Senate President Allen called the meeting to order at 3:37 p.m.

#### 1. Approval of Agenda

Senator Donadio made a motion to approve the agenda. Senator Smith-Andrews seconded. The motion carried.

# 2. Approval of Minutes and Notes from Previous Meetings

a.) January 29, 2024 Business Meeting Minutes

Senator Donadio made a motion to approve the minutes. Senator Atkinson seconded. Senator Smith-Andrews abstained. The motion carried.

b.) February 5, 2024 Meeting with Provost Bruce Notes

Senator Smith-Andrews made a motion to approve the notes. Senator Atkinson seconded. The motion carried.

## 3. Report from Academic Council Chair

Senators discussed issues and confusion with reserving space for classes through Coursedog; this may need to be a future agenda item for discussion. The best advice is to work ahead and together as much as possible.

#### 4. Report from Administrative Council Chair

No updates; the council has not met since the last report.

#### 5. Report from TUFS

Senator Smith-Andrews reported on the latest TUFS meeting topics, including shared governance and a history of low and inconsistent pay for adjunct instructors.

## 6. Discussion with Vice President Braswell from Advancement

VP Braswell updated senators on fundraising goals and changes in funding the department. Advancement has met 44% of the funding goal after 45% of the time has passed for this funding campaign. The department seeks to raise these funds primarily for faculty support, scholarships, and student experiences. VP Braswell offered to meet with anyone who had any further questions or discussion.

# 7. Report from Trustee Luna

The next Board of Trustees meeting is coming up a week from Thursday. There is not yet any information on the Mercer study and Trustee Luna was told the board would be reviewing results at the March meeting.

### 8. Report from the Faculty Senate President

The recent meeting of the President's Cabinet held information about the Mercer study. According to Mercer, faculty salaries are on average 5% below the median, though some units may have higher or lower percentages. Staff salaries are on average 16% below the median. President Oldham proposed correcting the averages closer to the median over the next four years. The first year's effort will use the \$1.7 million set aside to correct some salaries (retroactive to January 1). Senate President Allen shared a discussion in Cabinet he had with concerns about using merit pay to achieve market targets. Senate President Allen offered to President Oldham to work on a model to achieve market without merit to see if it can be applied to all departments. Senate President Allen solicited volunteers from the senate body to help achieve this in the next week. Some senators expressed hope that staff salaries be prioritized first and further concerns about using merit pay to achieve market medians.

## 9. Discussion on Budget Advisory Committee meeting

The BAC did not get the budget information ahead of the meeting; President Oldham shared it in the meeting. This will be a "lean year" as the state is dealing with a \$1.2 billion lawsuit. President Oldham and VP Stinson are going to make pleas to the state. The lawsuit is in regard to an excise tax overcharge according to one senator.

#### 10. Discussion on Faculty Handbook

Senate President Allen discussed with Provost Bruce issues with the current Faculty Handbook. In question is whether the Faculty Handbook website is a duplication of information elsewhere, and what purpose the Handbook serves or needs to serve. Senators are encouraged to speak with colleagues about the Handbook and its future before discussing this in a future Senate business meeting.

## 11. Discussion of Tennessee House Bill 2348, proposed

Senator Troy Smith encourages all to look at the bill as it is deeply concerning. The bill introduces felony consequences and further defines restrictions regarding divisive concepts.
