 Proposal from the College of Education, Department of Curriculum and Instruction to update the program of study for the Specialist degree Educational Technology concentration, effective Fall 2025.

Comments/Amendments: Dr. Wendt stated the change to the Program of Study for Educational Technology concentration, EdS. was needed because of a discontinued course, CUED 7430. The total credit hours is the same. CUED 7430 was removed from the core coursework and 3 credit hours was added to the advisor guided electives.

5. Proposal from the College of Interdisciplinary Studies, School of Environmental Science to add a thesis option and reduce the credit hours from 33 to 30 credit hours in the Environmental Informatics concentration; to add two concentrations, Environmental Science and Environmental Sustainability, both with thesis and non-thesis options, effective Summer 2025. *AC

Comments/Amendments: Dr. Mattingly referred to the new courses approved in Spring were to help modify the concentrations. The current proposal will change the credit hours, add new courses to the program of studies, add a thesis option to the Environmental Informatics concentration, unify the core coursework for all concentrations, and add two new concentrations (Environmental Science and Environmental Sustainability) bring the total to three Environmental Science concentrations. All three concentrations will have a non-thesis and thesis option and an

internship will remain in the thesis option. The changes will give more freedom in electives and will improve the original, allowing for a better fit. Memos were added for the two new concentrations to provide information regarding admissions (same as Environmental Informatics), Fast Track participation (same as Environmental Informatics), and catalog descriptions.

Dr. Kalyanapu asked about the possibility of engineering interactions or involvement. Dr. Mattingly responded that electives could definitely be in engineering. Students may not have prerequisites so it is not assigned.

6. Proposal from the College of Engineering, Department of Civil and Environmental Engineering to add a new course: CEE6380 Earthquake Ground Motion Analysis, effective Fall 2025.

Comments/Amendments: Dr. Mackenzie stated that the department has faculty qualified to teach and it makes sense to offer a course about earthquakes. The question was asked if Tech had earthquake simulation equipment. The answer was not specifically but equipment from other areas may be used and there is computer software available.

7. Proposal from the Whitson-Hestor School of Nursing to replace the Master of Science in Nursing admission requirement of 3 letters of recommendation with 3 professional references, effective Summer 2025. *AC

Psychiatric/Mental Health Nurse Practitioner, Family Nurse Practitioner, Nursing
Education, and Nursing Administration.

8. Proposal from the College of Interdisciplinary Studies, School of Professional Studies to reduce the number of credit hours required for department certificates from 15 to 12 credit hours, effective Fall 2025. The credit hour change for certificates does not affect the credit hours of the Master's degree programs with embedded certificates. *AC Certificates included: Healthcare Informatics, Human Resources, Project Management for the Professional, Public Safety, Strategic Leadership, Training and Development, and Teaching English to Speakers of Other Languages

Comments/Amendments: Dr. Tennant said that when the certificates were original created they were under the impression that all graduate certificates must be a minimum of 15 credit hours but upon review, the minimum is 12 credit hours. (Undergraduate certificate minimum is 15 cr, Graduate certificate minimum is 12 cr hrs.) Changing the certificates credit hours will allow for more flexibility and be more appealing to students.

Dr. Gotcher add that the hope is to be able to allow students to customize their studies, truly and interdisciplinary degree.

Dr. Camuti added that APSU offers micro-credential certificates.

Wording was updated to be more precise in the variety of programs able to

participate in the certificate.
