- 3. Proposal from the College of Agriculture and Human Ecology, School of Human Ecology for the following changes and additions effective Fall 2025:
 - a. Edit the Community Health and Nutrition program by adding an option to the degree only pathway; Change the experiential learning pathway practicum plan and replace course PRST6540 with HEC6640.
 - Add courses HEC6640 Review of Nutrition and Dietetics and HEC5100 Cultural Competence for Professionals.
 - c. Edit the course title of HEC5025 from Cultural Issues Influencing Health to Cultural Practices Influencing Health

Comments/Amendments: Dr. Samantha Hutson presented. Note that the program did have to change the course number for HEC6640 (from HEC6540) because of a number conflict. HEC6640 will be offered in the students' last term to better prepare them for their exams. Course additions will support the new Child Life program. HEC 5100 is currently offered at the 3000 level and the program wants to bring the course up to the graduate level to support the new program. The name change for HEC 5025 (from Cultural Issues Influencing Health to Cultural Practices Influencing Health) will better represent what is being covered in the course. For the Community Health and Nutrition program changes, the first change on the POS is providing another course option (HEC6640) to the degree-only pathway; degree-only students typically already have their credentials. For the experiential pathway, courses will be shifted around because having two practicum courses in the summer can be a heavy burden. Spreading out the practicums throughout the program. A course is also being replaced in the program of study. The credits are the same.
