**Threshold of Acceptability**: The enrollment threshold for Political Science is 75 students; if our number of majors fall below that threshold we will increase our recruitment initiatives. The 6-year graduation threshold of acceptability for Political Science is 55% and if the program's rate falls below that, tutoring will be emphasized. Graduation: Fall 2015 cohort: 59.9% graduated within 6 years from Tennessee Tech.

- 1. The Program is dedicated to remaining involved in recruitment initiatives including TTU Fall Preview Day and Spring Showcase during which we give out TTU "swag" to prospective students.

**Threshold of Acceptability**: The threshold of acceptability for the student-evaluated curriculum map is that the students determine a majority of the courses prepare them for written and oral communication as well as prepare them for proficiency in their concentration. 1. The California Critical Thinking Skills Test (CCTST) is a senior exit exam taken by all graduate seniors at Tennessee Tech University. Political Science majors will average 90% of the TTU average on the California Critical Thinking Skills Test (CCTST):

**Threshold of Acceptability:** Faculty seek to emphasize student critical thinking gains through use of the California Critical Thinking Test as a component of SLO 1. Specifically, students must score 90% of TTU's mean score on the CCTST.

2. Educational Testing Services (ETS) major field examination is administered each fall and spring semester to all enrolled majors with senior classification. The ETS exam measures Analytical and Critical Thinking, Methodology, and Political Thought.

**Threshold of Acceptability:** Students should demonstrate at least ten point gains each semester on the General Education POLS 1030 Pre/Post. If this rate of gain drops, review sessions will be offered.

2. Educational Testing Services (ETS) major field examination is administered each fall and spring semester to all enrolled majors with senior classification. The ETS exam outlines content questions related to Comparative Government and Politics, International Relations, and United States Government and Politics.

**Threshold of Acceptability:** Performance at a level within 10% of the national mean on the ETS Major Field Examination Sub Score content areas is expected. If scores are below the national mean, faculty will re-evaluate.

## **Modifications for Improvement:**

- 1. The California Critical Thinking Skills Test (CCTST) was added as a new measure of critical thinking in 2020-2021 and Political Science continues to score well on this measure. The CCTST is a senior exit exam taken by all graduate seniors at Tennessee Tech University. The University expects program scores to be above a 90% threshold in comparison to the TTU institutional score with the goal of 100%.
- 2. To expand curricular options, Political Science and Sociology now house the NSF-grant funded "Cyber Crime, Law and Society Minor" in collaboration with the College of Engineering. See Appendix 2 for Curriculum.

**Threshold of Acceptability:** Political Science and Sociology anticipated 5-10 students to be interested in the grant-funded minor three years ago when first writing the NSP application with PI Dr. Ambareen Siraj. Ten students in the POLS 1030-777 CYBER sections remains the acceptable limit. This fall the section had to be opened from an initial enrollment of 25 to a double section.
