Abstract:	Henry Brooks Algood (1860-1934), a druggist who owned Algood Pharmacy in Cookeville, was the son of Joel Algood, for whom the town of Algood was named. His wife, Frances "Fannie" Crutcher Algood (1862-1936) traveled across the United States purchasing ladies' hats and accessories to sell to the women of Putnam County. This collection contains ledgers, financial records, receipts, and other materials that belonged to Henry and Fannie.

Biographical / Historical

The Algoods were a prominent family living in Putnam County. Joel Algood (1808-1861), for whom the town of Algood was named, was a civil engineer and Methodist circuit preacher who married his second wife, Nancy Wilson Moore Algood (1819-1897), in 1848. The couple had five children: William

Algood (1849-1859), George Algood (1852-1854), Alfred Algood (1855-1925), Mary Algood Boyd (1857-1877), and Henry Brooks Algood (1860-1934).

William and George did not survive into adulthood. Mary died at the age of nineteen, only a year after marrying Houston Savage Boyd (1851-1881).

Alfred became an attorney and married Lula Payton Williams Algood (1861-1943), with whom he had two daughters named Virginia Wilson Algood (1897-1902) and Margaret Rosalind Algood Vaden (1901-1990). Henry, a pharmacist who owned Algood Pharmacy in Cookeville, married Frances "Fannie" Crutcher Algood. Fannie was among several local women who traveled around the country purchasing women's hats and accessories to sell in the Putnam County area.

The Algood United Methodist Church was built on land donated by Henry and Alfred.

Content Description

The Algood Family collection primarily contains materials related to Henry Algood's pharmacy work, Fannie Algood's millinery work, and the Algood family's financial records. These materials would prove useful for research involving Putnam County, the town of Algood, and pharmaceutical practices in the late 1800s and early 1900s.
