#### **REQUEST FOR QUOTATION**

Tennessee Technological University is requesting quotations from qualified companies to provide Crane and Rigging services for the relocation of a wind tunnel and other services as needed at the Tennessee Tech Crossville Research Center. The contract term will run from date of final signature through five (5) years thereafter.

Prices submitted by Contractor are to remain firm for a one (1) year period. Contractor may request a price increase, thereafter, to the extent such increase has been experienced by Contractor and can be substantiated in writing. Tennessee Tech may accept requested price increase or choose to rebid, at its sole discretion.

All services must be provided in accordance with the specifications outlined below and in compliance with applicable safety and regulatory requirements.

# **Scope of Work / Specifications**

The selected Contractor shall provide all equipment, operators, and labor necessary to perform rigging and crane operations as requested by Tennessee Tech personnel. The scope includes, but is not limited to the following:

- Provide a rate schedule for all available equipment and labor, as well as for any subcontracted or purchased services (e.g., wide load escorts, permits, etc.).
- When contacted by Tennessee Tech employees, the Contractor must either:
  - Schedule equipment and operators to move items as needed at the time of the initial call, or
  - Respond within four (4) hours of the initial call during regular business hours.
- In the event of an emergency (e.g., mechanical or utility issues) the Contractor must provide a rapid response time of no more than one (1) hour from the initial call, regardless of business hours.
- The Contractor shall provide Tennessee Tech with an up-to-date on-call schedule and contact information for key personnel. Tennessee Tech will designate a point of contact to coordinate these updates.
- Work will be conducted primarily during normal business hours.
- No work shall be performed on Sundays or on official holidays unless the work falls under emergency operations.
- All safety regulations and requirements must be followed at all times. Personnel must wear hard hats in designated areas.

Note: For the purpose of this contract, normal business hours are defined as 7:00 am to 4:00 pm, Monday through Friday.
