Required CITI Training for Departmental Reviewer

All faculty or staff at Tennessee Tech serving as a Departmental Reviewer on all IRB Applications for Research Involving Human Subjects must complete training in the responsible conduct of research, ethics in human subject research training, and training specific to Departmental Reviewers.

TTU Policy 730 (Institutional Review Board) requires all researchers, board members, and faculty supervisors to complete human subjects training. TTU Policy 750 (Responsible Conduct of Research) requires all researchers and board members to complete training in the responsible conduct of research.

In the CITI training website, the required training includes:

- Social and Behavioral Responsible Conduct of Research" and
- > "SBE Researchers including all students and faculty acting as an Investigator (PI-co-PI)"
- "Departmental Reviewer"

Each training course has a number of modules. Each module should take about an hour to complete; however, an entire course does not need to be completed in one sitting. Each course consists of 13-16 brief modules, and, at the end of each module, you will need to complete a two- to five-question quiz. The courses must be passed with an 80 or higher.
