- XI. New Business
  - a. Senate Confirmations
    - i. Grady Cox College of Arts & Sciences
      - 1. Sen. Zak Henson moved that the Senate approve the recommendation of the Commission for Nominations that Grady Cox be appointed as a Senator for the College of Arts & Sciences, which was seconded.
      - 2. Seeing as there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominee.
      - 3. The nominee was confirmed with 15 members voting Aye, 0 members voting No, and 0 members abstaining.
    - ii. Sydney Looper & Abby McCulley (College of Education); Cole Strickland (College of Engineering); Kelsey Rainey & Omar Abdelsalam (College of Graduate Studies); Elizabeth Ross (College of Interdisciplinary Studies)
      - 1. Speaker Simpson entertained a motion that the remaining recommendations of the Commission for Nominations concerning Senate seats be considered *en bloc*. Sen. Henson made the aforementioned motion, which was seconded. Without objection, the motion is adopted.
      - 2. Seeing as there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominees.
      - 3. The nominees were confirmed with 16 members voting Aye, 0 members voting No, and 0 members abstaining.
  - b. Supreme Court Confirmations
    - i. Eli Anderson & Emma Parson (Associate Justice)
      - 1. Speaker Simpson entertained a motion that the recommendations of the Commission for Nominations concerning Supreme Court seats be considered *en bloc*. Sen. Nucum made the aforementioned motion, which was seconded. Without objection, the motion is adopted.
      - 2. Seeing as there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominees.
      - 3. The nominees were confirmed with 22 members voting Aye, 0 members voting No, and 1 member abstaining.
  - c. Cabinet Confirmations
    - i. Amayalei Clark (Secretary of Environment and Health) & Sara Owens Secretary of Innovation and Technology
      - 1. Speaker Simpson entertained a motion that the recommendations of the Executive Council concerning the nominees for Executive Cabinet be considered *en bloc*. Sen. Rainey made the aforementioned motion, which was seconded. Without objection, the motion is adopted.
      - 2. Seeing as there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominees.

3. The nominees were confirmed with 22 members voting Aye, 0 members voting No, and 1 member abstaining.

#### d. Information Items

- i. Promulgation of Supreme Court Rules for Case Referrals
  - 1. Associate Chief Justice Montgomery presented the rules adopted by the Supreme Court concerning case referrals as required by the First Judiciary Act of 2024.

#### e. Other New Business

- i. Adoption of Senate Standing Rules
  - 1. Speaker Simpson gave opening remarks on the proposed revised Senate Standing Rules. Subsequentially, Speaker Simpson entertained a motion that the Senate adopt the revised standing rules. Sen Henson made the aforementioned motion, which was seconded.
  - 2. As there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the revised standing rules.
  - 3. The proposed standing rules passed with 23 members voting Aye, 0 members voting No, and 0 members abstaining.

#### ii. Election of Senate Officers

- 1. Speaker Pro Tempore
  - a. Speaker Simpson opened the floor for nominations for the office of Speaker Pro Tempore. Subsequently, Sen. Henson nominated Sen. Nucum for the office, which was seconded and accepted.
  - b. Seeing as no other nominations were made, Sen. Rainey moved that the Senate elect Sen. Nucum to the office of Speaker Pro Tempore by acclamation, which was seconded.
  - c. As there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominee for Speaker Pro Tempore.
  - d. Sen. Nucum was elected to the office of Speaker Pro Tempore with 23 members voting Aye, 0 members voting No, and 0 members abstaining.

#### 2. Chief Clerk

- a. Speaker Simpson opened the floor for nominations for the office of Chief Clerk. Subsequently, Sen. Nucum nominated Sen. Van Tuyl for the office, which was seconded and accepted.
- b. Seeing as no other nominations were made, Sen. McCulley moved that the Senate elect Sen. Van Tuyl to the office of Chief Clerk by acclamation, which was seconded.
- c. As there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominee for Chief Clerk.
- d. Sen. Van Tuyl was elected to the office of Chief Clerk with 23 members voting Aye, 0 members voting No, and 0 members abstaining.

#### 3. Parliamentarian

- a. Speaker Simpson opened the floor for nominations for the office of Parliamentarian. Subsequently, Sen. Looper nominated Sen. McCulley for the office, which was seconded and accepted.
- b. Seeing as no other nominations were made, Sen. Casebier moved that the Senate elect Sen. McCulley to the office of Parliamentarian by acclamation, which was seconded.
- c. As there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominee for Parliamentarian.
- d. Sen. McCulley was elected to the office of Parliamentarian with 23 members voting Aye, 0 members voting No, and 0 members abstaining.

#### 4. Sergeant-at-Arms

- a. Speaker Simpson opened the floor for nominations for the office of Sergeant-at-Arms.
- b. Sen. Gibbs nominated himself for the office, which was seconded and accepted.
- c. Sen Strickland nominated Sen. Henson for the office, which was seconded and accepted.
- d. Seeing as no more nominations were made, Speaker Simpson closed debate and moved the chamber into a period of voting on the nominees for Sergeant-at-Arms using approval voting.
- e. Sen. Henson was elected to the office of Sergeant-at-Arms after an instant runoff phase, with 15 members indicating an overall preference for Sen. Henson, 2 members indicating an overall preference for Sen. Gibbs, and 5 members indicating no overall preference.

#### f. Bills and Resolutions

- i. S.B. F24-005 S.O.L.O. General Fund Procedures Act
  - 1. Sen. Henson gave opening remarks on S.B. F24-005. Subsequentially, Sen. Henson moved that the Senate adopt the aforementioned bill, which was seconded.
  - 2. As there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on S.B. F24-005.
  - 3. The bill passed with 23 members voting Aye, 0 members voting No, and 0 members abstaining.

#### g. Committee Breakouts

- i. Academic Affairs and Student Life
  - 1. The Senate recessed to allow the Academic Affairs and Student Life committees to meet.
- ii. Campus Outreach, S.O.L.O. Funding, and University Infrastructure
  - 1. The Senate remained in recess to allow the Campus Outreach, S.O.L.O. Funding, and University Infrastructure Committees to meet following the adjournment of the Academic Affairs and Student Life committees.
  - 2. Subsequently, Speaker Simpson called the Senate back to order.

### h. Budget

- i. Treasurer Bare presented the proposed budget for the semester. Subsequently, Sen. McCulley moved that the Senate approve the budget, which was seconded.
- ii. As there was no debate, Speaker Simpson closed debate and moved the chamber into a period of voting on the budget.
- iii. The budget was approved with 23 members voting Aye, 0 members voting No, and 0 members abstaining.

#### XIII. Adjournment
