

Minutes from the Supreme Court | April 4th, 2024

Regular Meeting

The Supreme Court of the Student Government Association of Tennessee Tech met at 6:49pm on April 4th, 2024, in the Center for Student Engagement Conference Room of the Roaden University Center. Chief Justice Bryson Lee was present and presiding. Chief Justice Lee took the roll, and a quorum was established. The minutes for March 5th, 2024, were sent out at least three days prior to the meeting of the Supreme Court on April 4th, 2024, and considered read without objection. The minutes dated March 5th, 2024, stand approved. The agenda attached as Appendix A was adopted as the orders of the day.

Chief Justice Lee **MOVED TO ADOPT** Associate Justice Lela Gracy as the new Secretary of the Supreme Court for the rest of the duration of the 2023-2024 Supreme Court. Chief Justice Lee ordered the question which was **ADOPTED** with **6 AYES** and **0 NAYS**. Lela Gracy will now act as both an Associate Justice and Secretary of the Supreme Court.

Chief Justice Lee **MOVED** that the last meeting to be held April 16th, 2024, should take place at a restaurant in Cookeville. This was seconded by Associate Justice Cailey Martin. A poll was sent out with 5 different options.

Chief Justice Lee brought forth the issue of summer meetings. It was decided by the Supreme Court that a summer meeting would only be held if deemed necessary, such as, in the instance of a case.

Chief Justice Lee opened the floor for any announcements to be made. Chief Justice Lee announced several informational items, such as, the New SGA Constitution and vacancies in SGA, the upcoming Safety Walk, and the SGA Banquet. The Supreme Court was informed by Chief Justice Lee that there are several vacancies throughout SGA, and to ask those that they think might be interested to join. The Safety Walk is scheduled for April 9th, 2024, at 6:30pm and the SGA Banquet is scheduled for April 15th, 2024, at 6:30pm. No further announcements were made.

Chief Justice Bryson Lee moved to adjourn the meeting of the Supreme Court if there were no other announcements. The Supreme Court **ADJOURNED** at 7:16pm until their next meeting on April 18th, 2024, at 6:30 at Chili's on Interstate Drive, Cookeville, TN.
