# **JUNE 2025**

Throughout the month of June, the Talon team continued with System Integration Testing (SIT 1) and experienced a giant win during Parallel Payroll Testing (PPT 1).

The Payroll team tested the efficacy of the new system by concurrently running payroll through our current system as well as through Talon. The expected threshold for PPT 1 was 80% accuracy, and the Payroll team crushed that goal, with monthly payroll matched records validated to 97% and biweekly payroll matched records validated to 93.8%.

The success of this first Parallel Payroll Testing is an exciting and promising start to the successful transition to the new Talon system.

# What's Ahead in July

SIT 1 will continue through July, with SIT 2 and PPT 2 starting in September. Defects found during SIT 1 are currently being addressed and reviewed to ensure positive outcomes during SIT 2.



Campus-wide training will begin in October and last through 2026 to help all users transition effectively to the new system.
